

# **FDM2025 CHOCOLATE WONDERLAND**

## **GIVEAWAY Contest Terms & Conditions**

Terms and Conditions as at 9 June 2025

### **Contest Details**

1. FDM2025 Chocolate Wonderland Giveaway (“Contest”) is organised by Comexposium Sdn Bhd (“Organiser”)
2. The contest period shall be from 1 – 3 July 2025.
3. The prize announcement shall be held on 3<sup>rd</sup> July 2025 at MITEC Kuala Lumpur.

### **Eligibility**

1. The contest is open to all trade visitors of Food & Drinks Malaysia by SIAL 2025 (“FDM2025”) who meet the requirements below, except for employees of Comexposium and its affiliated companies, joint venture partners, exhibitors, contractors, suppliers, and sponsors of Food & Drinks Malaysia 2025.
2. In order to be eligible to participate in this Contest, a contestant must fulfil the following requirements:
  - a. The contestant must be an attendee of FDM2025 and is involved in the food industry or related sectors;
  - b. The contestant must have completed the contest entry form at the Food & Drinks Malaysia 2025 by SIAL exhibition booth in MICE 2025, or;

- c. Check-in at the Chocolate Show exhibition segment during the exhibition period.

### Prizes

1. A total of ONE (1) Prize will be given in this contest.
2. The Prize comprises:
  - a. One (1) return flight ticket in economy class with basic baggage allowance of either Malaysia Airlines, AirAsia, or any other flight deemed suitable by the organiser.
